





Wreaths were laid at The Causeway war memorial in honour and remembrance of those who died in the Far East campaign, which ended in August 1945.

We are still planning to hold the Christmas Lights Switch On and Shop evening on 19th November and Carols on The Causeway on 17th December – we will let you know if there will have to be any changes to the usual arrangements for these very popular pre-Christmas events.

Also cancelled this year was my mayor's charity golf day, but this now been re-arranged for 20th April 2021. This is a major fundraising event for my charity, which is supporting mental health issues for young people in Marlow. With the agreement of last year's Mayor, Cllr Chris Funnell, we are combining the two years' funds, so that we can support this ongoing programme, the demand for which continues to grow. To widen the scope of this and future fundraising, the Town Council recently approved the setting up of a formal charity and this is now registered with the Charities Commission as "The Marlow Mayor's Charity".

The Marlow community spirit has continued to show through and there are still individuals and groups helping vulnerable residents in many parts of the town. So again,




a sincere 'thank you' to all those who have helped with many community initiatives during this difficult time.

Summer hanging baskets and troughs have been installed throughout the town. The Council has also arranged the watering of plant displays normally looked after by businesses closed due to the lockdown.



Please help keep the town tidy _

Many street litter bins are being left overflowing with rubbish. Bin collections are taking place as usual but please do not place domestic waste in street bins. If the street bin is full, please take your litter home. Despite the many difficulties thrown up by Covid-19 in the past few weeks, Marlow Town Council has continued to ensure pathways and alleyways are cleared of weeds and overgrown plants around the town over the last weeks.

Community Payback, the Probation Service project, was unable to continue its weekly work during lockdown but started up again in June. The team has since cleared alleyways including: Trinity Road to Oak Tree Avenue; Trinity Road to Oak Tree Road; Foxes Piece to Newfield Gardens. They have also started clearing the perimeter of Gossmore Park. The Town Council's own Grounds Maintenance staff has cleared the alleyways at Seymour Park, the Rushes (off Henley Road) and from Victoria Road to Newfield Gardens.

Mayor Richard Scott said: "The Council recognises that the recent good weather and the exercise culture that has expanded rapidly during the Covid pandemic has seen more residents using the various footpaths and



cycleways around the town. We are delighted that a substantial number of these paths have now been cleared of vegetation to allow more space for all users."

Bushes elsewhere around the town that were crowding into pedestrian pathways have also been cut back. Work will continue on tidying up more roadside bushes and alleyways throughout the summer.



Marlow's pedestrian flow moves with the times

Marlow Town Council has announced changes to the advisory one-way pedestrian system in the town. The Council has been working closely with the Reopening Team at Buckinghamshire Council to monitor and review social distancing interventions.

The changes are in response to an increase in the numbers of residents and visitors using the town centre, coupled with an increase in applications for pavement licences from restaurants and cafes.


"Marlow is a friendly and welcoming town and is open for business," Mayor Richard Scott said. "We want to help our retailers to trade, which means encouraging more people on to our streets. With the increase in people visiting the town and new outdoor seating for cafes and restaurants in the pipeline, we've made some changes to the pedestrian one-way system to add more flexibility.

"We continue to ask our residents and tourists to respect a two-metre distance where possible and to share pavement space considerately with others. Please remember the importance of social distancing to keep everyone safe and be courteous and patient with others —especially on Marlow's narrow Victorian pavements. Please help us all to keep safe."

The majority of the High Street will now be two-way for pedestrians, with reminders for people to keep left to enable a smooth two-way flow and to be courteous at

'pinch points' — narrow sections of pavement — at the corner of the High Street and West Street and at the bottom corner of the High Street and Pound Lane. Spittal Street, with its narrow pavements, will retain its one-way flow, as will Marlow Bridge. New pavement stickers will be displayed on the High Street and West Street. WW



A-Boards

Marlow Town Council's A-Board policy has been in force now for two years. During this time officers have worked closely with local business owners to ensure that advertising boards are treated equally for all town centre businesses and do not obstruct footpaths. This is now even more important as we try to ensure social distancing on our narrow Victorian pavements. Confiscation of offending boards is a last resort and officers will ensure that the rules are enforced fairly.



Get On Board

Policy for using A-Boards to promote your business

Why do we need an A-Board policy? ____

To make clear what A-Boards are permitted in Marlow and what restrictions there are on businesses wishing to display them, Marlow Town Council have put together guidelines below. Pedestrians, disabled people, particularly those with visual impairment and people with pushchairs can have difficulty getting round them. A-Boards can also affect road safety and visibility if inappropriately used.

It is important that the number, size and position of these A-Boards are controlled and that they do not become unreasonable and cause difficulties to pedestrians. However, we recognise that they are an important way for businesses to communicate with shoppers and visitors. We also seek to promote consistency, fairness and to support the High Street.


What is an A-Board ? _____

An A-Board is a portable free standing advertising sign designed to be placed on the ground, if you use these signs on public land or adjacent to highways then you must comply with these rules.

Rules for the use of A-Boards _____

If you wish to use an A-Board to promote your business on public land or adjacent to the highway you will need to make sure that you follow the rules below:

- Businesses must only have one board directly outside their own premises leaving a gap of no less than 1.5 metres to the kerb edge, and place it against the frontage or property boundary.
- Businesses who do not have a frontage on the main pedestrian routes, will be permitted to place a board in





a nearby sensible location, as long as they comply with the sizes and measurements detailed.

- New boards will be no more than 600mm wide at any location. Boards already on display that are larger but still allow 1.5 metres to the kerb edge will be permitted.
- Board size and location will always be at the discretion of Marlow Town Council officers.
- If any board breaches these rules officers will take action first in the form of a verbal notification, followed by a written notification. If the situation is still not rectified the board will be removed and the owner notified.
- Marlow Town Council will charge a recovery fee of £100, plus VAT, for any board that has to be removed following failed verbal and written notifications to the owner.
- Any board must be covered by the owner's public liability insurance.
- Vibrant colours are not appropriate in a conservation area.
- It must be stable and not weighted down or tied.
- It must not obstruct visibility at junctions.

Update from Marlow Town Council's environmental initiative

As this article is being written, we are still in the midst of this awful pandemic. We hope that all Marlovians are well and taking great care. This has had such an impact on so many areas and has slowed us down on some of our activities, and we had to cancel some. But as we start to come out of lockdown, we sincerely hope to make renewed progress and to "build back better".

Sadly we were forced to cancel the Eco-Schools Conference we had planned for late March. This was an innovative day, bringing together students from every Marlow school to discuss and learn about environmental issues. Local environmental projects and specialists of many different kinds had volunteered to contribute. As soon as we can we will set it up again.

Sustainable Marlow took part in a recent online showcase for local environmental projects, organised by community group the Marlow Climate Action Network (MCAN). Over three evenings in June and July representatives of many local environmental projects introduced their activities and aims via a webinar. All the presentations are being made available by MCAN on YouTube.

We gave an overview of Sustainable Marlow and described our statement on climate change and our Clean Air Plan, both formally adopted in March. On climate change, Marlow Town Council has pledged to reduce its greenhouse gas emissions to net zero as quickly as possible. To this end it is now calculating its carbon footprint and will publish the results in due course. In the Clean Air Plan, the Town Council determines to add to its efforts to tackle the air pollution problem in Marlow town centre. The plan sets an objective for eliminating illegal levels of nitrogen dioxide within five years.

Other Sustainable Marlow presentations during the MCAN events included introductions to the Releaf Marlow street tree-planting project; Refill Marlow, encouraging alternatives to disposable plastic drinks bottles; and the Marlow Eco-Schools Network.

Back in the real world, Sustainable Marlow environmental efforts have been progressing, even though hampered by the Covid-19 lockdown.

In order to fight traffic-derived air pollution in Marlow town centre the Council has been communicating with drivers via overhead banners. Though two banners were unfortunately lost to unseasonably high winds, we have returned with a third that will hang over Spittal Street. Its message is simple: it urges drivers to "reduce speed" and to "drive smoothly" so as to cut pollution.



Meanwhile, a new drinking water fountain and bottle refill station on The Causeway is now fully installed. Before we make it available for use, we are reviewing how to make it Covid-secure. We hope to have two other new bottle refill sites confirmed in the next couple of months.

We have also begun experimenting with wild grass verges for the benefit of wildlife, working with recently formed local community group Wild Marlow. We trialled leaving some grass areas unmown this spring with some reasonable results. This led us to spending some time researching how to achieve better results from wild flower planting and the best time of year to start the process. We hope to have more news on this in due course and to start expanding the area of wildflower verges in 2021.


A key aim of the new Buckinghamshire Council is to strengthen relationships with our communities through the creation of 16 Community Boards to connect with local communities, make space for community conversations, respond to local needs and tackle issues together.

Building on how people came together quickly in response to Coronavirus, these Boards are now becoming a reality, with chairman and key coordinators appointed and introduction meetings in August. These meetings are the start of the conversation, taking a look at key issues in the local area, how the boards will work and who to involve across the community. This new way of working will bring the Council, groups, organisations and people together to explore issues and take action through local working groups, backed by a £3.9m budget to fund local initiatives and creative solutions. This will be where the real change take place.

Court Garden Leisure Centre reopens



The team at Court Garden Leisure Centre, led by Nicola Allen, all worked hard to get the Centre ready to welcome customers back from 17th August.


Over the last few months the refurbishment work that has seen £2m invested in the site has been taking place. Despite losing several weeks in April and May during the lockdown, the contractors were back working on the Centre as soon as the restrictions on construction were eased.

The site has a new roof and boilers, changing rooms have been refurbished and the swimming pool is now bright and airy with its new roof, swimming pool liner, retiling, and completely renewed changing areas. The sports hall has had a new sprung floor installed and the exercise areas and theatre space have been redecorated. Customers returning to the Centre will also notice the makeover in the reception area.

The closure of all leisure centres across the country due to the Covid–19 pandemic has been a very challenging time for everyone. In order for centres to reopen, there has been a great deal of work undertaken to ensure sites can meet the new guidelines so customers can enjoy a safe return to exercise. The Centre has reopened in phases with gym and exercise classes from 17th August, the swimming pool from 24th August and swim lessons from 7th September. Customers will notice a difference when they return. All sessions have to be booked in advance, customers have to come activity-ready, there will be a one-way system through the building with clear information and staff on hand to assist customers. Hand sanitisers are now located throughout the Centre and there is an enhanced cleaning regime in place. Capacity in the gym and classes is reduced to meet social distancing requirements and there will be lane swimming in the pool as well as the opportunity for family groups of up to five to book a session.

Places Leisure and the Court Garden team have put lots of helpful information on their website including a frequently-asked-questions page which will help everyone to plan and book their first visit back. Please take a look and get ready to enjoy your activity at Court Garden again soon.

This includes asking anyone attending a surgery to wear a face covering, unless you are exempt from doing so; and encouraging patients to continue utilising online services wherever possible.

Like GP surgeries nationwide, Marlow Medical Group has worked tirelessly to ensure that the surgery continued to operate safely and effectively, whilst also embracing technological innovations where possible to ensure patients retained access to clinical advice throughout the pandemic. The use of many of these resources is likely to continue for the foreseeable future.

For example, the use of video consultations has enabled our clinicians to hold clinics even when working from home; and the ability for patients to provide photographs where necessary by text message reduces any unnecessary risk in attending the surgery. To date, the feedback we have had suggests that these services are incredibly effective for a large number of our patients.

Remembrance & Poppy Appeal

Fundraising and commemoration during Covid-19 lockdown

A big thank you to the Marlow Community for what has been achieved in the Poppy Appeal collection since October last year. Unfortunately, the Covid-19 lockdown has affected the overall amount as other money-raising activities had to be cancelled. Nevertheless, Marlow raised a total of £32,000, a magnificent achievement.

Covid-19 has badly affected events so far this year. The cancellation of 'VE' Day events was particularly aggravating, as a special 'Thank You' to World War II veterans had been planned. Unfortunately a similar celebration for 'VJ' Day has not been able to go ahead either; the Poppy Appeal and Remembrance Sunday arrangements are also in question.

This year's Poppy Appeal will be different from previous years. The Royal British Legion has had to consider the safety and wellbeing of its volunteers and contributors. With social distancing in force, it would be impossible to conduct street collections, house-to-house collections and delivery of collection boxes. Other fundraising events, yet to be announced, are being examined on a national basis.

The loss of the town's generous contributions to the Poppy Appeal would be devastating. This would be an exceptional arrangement for this year because of Covid-19. Sunday would also be impossible to hold under the current Government regulations. The Remembrance Commemoration is a civic event and the Town Council will be keeping the situation under review in line with any changes of the regulations. A cut-off date is likely to be in September so that arrangements can be finalised in time. Safety is the priority of both the Council and the Royal British Legion. Both want to ensure that no one's life is put at risk, especially veterans and older and vulnerable members of the congregation. The worst case will be that there will no parade this year but the possibility of a virtual commemoration will be examined.



The organisers have 3,000 Santa suits in stock and 3,000 official Runner Cards printed. And, to reflect changing circumstances, they have made some very important changes:

- For the first time all children aged five and over will receive a Santa Suit (suit availability subject to demand).
- Individuals and teams are invited to create their own Virgin Giving sponsorship pages.
- This year £5,000 in fun 'prizes' has been made available (NOTE the prizes are additional awards to charities charities that runners choose).
- Prices have been reduced (just a little it all goes to charity!).
- And, as with any virtual event, this can be done anywhere. In Marlow, in South Bucks, in the UK, or even in Australia.

John Prout, Chair of the Santa's Fun Run organising committee, said: "This year is different – but, despite all the uncertainty, the main thing is that the Marlow Santa's Fun Run will take place. Last year we raised around £50,000 for mainly local charities – and they need our help more than ever. The Rotary Clubs of Marlow have decided that we will not let them down – but we really do need help from anyone who has a connection with Marlow in order to do this".

"The event could in fact be the biggest ever," John said. "Over the weekend of 5th and 6th December we want the parks and streets of Marlow and South Bucks filled with socially distanced Santas. Lead sponsor the Shanly Foundation has continued its support – despite there being no traditional run. And Allergan (now part of the AbbVie group) has also continued the support first seen in 2019. As a result we have been able to commit to significant set-up costs – and of course allocate £5000 in "prize" awards to nominated charities. We thank our sponsors so much".


