## **Allotment Rent Review**

### **Cemetery Fees**

We would like to apply the Marlow Bottom/Little Marlow fee structure for the interment/burial of spouses or immediate family members that no longer reside in Marlow into existing graves. These graves were purchased with the intent for couples or families to be interred together. Unfortunately, where a spouse or family member has relocated, they are not eligible for in-area fees and the out of area fees are too expensive for many families resulting in the graves not being used. By applying the Marlow Bottom/Little Marlow, we could keep it more affordable for families and a payment stream coming in as the cemetery fills up.
