
The Town and Country Planning (Environmental Impact Assessment) Regulations 2017 require a consultation period of 30 days. As the notification letters were processed on 23<sup>rd</sup> June, this gives a formal consultation period until 23<sup>rd</sup> July. In reality however, we will normally accept and report representations received up until the day the decision is made (or Planning Committee). This is likely to be December at the earliest.

The Environmental Statement (the document that is produced at the end of the Environmental Impact Assessment process) is visible on Public Access <u>here</u>. The document is called 'Environmental Statement', but has been broken down into volumes, chapters and non-technical summary for ease.

We are investigating the details of the applicant further and will provide an update on

the planning file (Public Access) if appropriate.

Given the scale of the development, it is likely to be considered at Strategic Sites Planning Committee. I have copied in the relevant officers, who are leading on this application for awareness.



I have to say that expecting the public to wade through 400 plus supporting papers within 4 weeks does not appear to give sufficient time to the public - many of whom may be away on holiday during the next few weeks.

I would therefore ask for a two-week extension. Please advise.
