Thank you for your speedy response on this issue, I am incredibly grateful for your advice and taking the time to look into this with your [REDACTED] [REDACTED] [REDACTED].

I think some decorative rocks would be a great initial step but I am conscious they can and possibly will be moved. I am not sure if the placement of a semi-permanent knee high fence would be acceptable?

I have attached an image of the idea we had in mind, these are normally erected around local parks and I believe would solve the parking, while also keeping in line visually with the local area. As a slightly higher structure too, this would also avoid any potential accidents from the public potentially falling over the rocks.

I appreciate this might be a bit of an ask but we would fully finance the project and can paint the wood a lovely white or green colour to help with the visuals but more than happy to go with the local authorities preference on this front.

Any thoughts on this potential idea, would be gratefully welcome.

Good Evening Jocelyn

I hope this email finds you well,

My name is [REDACTED] and I reside at [REDACTED] in Marlow with my parents I m reaching out this evening for some guidance and advice on a current and ongoing issue, which we are faced with daily by the side of our property

By our property is a grass verge, which we personally maintain and have looked after on behalf of the council for the last 10+ years, through the dedication of my retired father However, recently this once well kept area is slowly being destroyed by a parking issue with local trades man I have attached some images below on the issue at hand and as you can see this seems more like a car park rather than a beautiful verge and is leading to a copycat behaviour with other trades men in the area, even though there are double yellow lines I would like to think this issue will resolve by itself but it s been 2 months now and the owner having the work done has told me, it will continue for weeks to come

To try and solve this issue, we have gone down a number of avenues but unfortunately with little effect These include:

Speaking to the owners of the property having the work completed - Sadly they have been quite unhelpful and have encouraged their builders to continue parking, while also being personally rude to not only myself but my parents

We have also spoken to the builders, which some are understanding but other have been quite bullish and on occasion engaged in aggressive verbal behaviour, which as you can imagine is unacceptable given we are trying to kindly ask them to move for the benefit of the community and even makes my parents scared to go out when they are there

Additionally I have personally spoken with Bucks council and Marlow Town council but apart from noting that more traffic wardens would come round, nothing more can be done

Finally, I have also enquired about purchasing this land from the council, which I would be happy to do so I can put a small fence there but sadly this has been a tricky process, with no one being able to official confirm who owns this, including HM Land Registry

I will be brutally honestly this may seem small and insignificant to some but for my father ensuring the area is well kept is a personal hobby he has taken pride in for years, which as you can imagine does have a benefit for the wider community He often gets lovely compliments on how well he keeps the area but due to this issue and the abuse we receive, he s losing hope and is quite distraught that sadly very little can be done We also volunteer at the Marlow church to keep the graveyard area looking clean but to be honest my father and myself are questioning if we want to carry on, if this the way the local community is

As you can imagine, I hate to see both my parent in this condition being in essence bullied in their house and especially at retirement, they just want an easy life but this is being torn apart

Due to this, I wouldn t normally bother you with such a request but if there are any suggestion you could advise to help resolve this issue, I would be extremely grateful

Good afternoon Jocelyn,

I have noticed a triangular area of grass (marked out with wooden pegs) adjacent to the Wiltshire Road/Little Marlow Road roundabout. I thought this might have something to do with the multitude of coloured markings on the grass and pavements in this area, which seem to be for either gas, BT or Swish cabling and manholes. However, it also occurred to me that there might be a proposal to make this into a flower bed, which would be a lovely idea. If so, can I please alert you to the fact that it is common for those walking to and from the Wiltshire Road bus stops to cut across that area - either to go towards The Parkway or to go down Wiltshire Road and it would therefore make sense to lay footpaths on either side of the bed to avoid further damage to the grass.

Whilst on the subject of footpaths, some years ago (2013 in fact) I raised the problem of the missing sections of footpath in Little Marlow Road and Wiltshire Road, and I remember that Councillor Avery called to see me after he had looked at the locations and agreed that they were not very sensible scenarios. My original email said:

*1. Taylor Wimpey have recently installed a new cycleway/footpath running parallel to the sports facilities at Great Marlow School and Little Marlow Road. When undertaking this work, the small footpath from the original footpath to Little Marlow Road was dug up and has not been reinstated. This now means that it is not possible to cross the A4155 from the North side to the South side (adjacent to the Wiltshire Road roundabout) without negotiating rough ground, and is totally unsuitable for wheelchairs or pushchairs.*

*2. Taylor Wimpey have also upgraded the North side of the footpath that runs between Wiltshire Road and Wycombe Road, alongside the sports fields of Great Marlow School. However, while there is a footpath at the bottom of this path to allow pedestrians to cross Wiltshire Road from North to South, there is no corresponding footpath on the South side of Wiltshire Road, so that pedestrians have to negotiate the grass verge and again this is not*

*safe for wheelchairs or pushchairs.*

Bucks Council subsequently issued a CRN number (415397) but to date nothing has happened. Would it be possible to include these 2 relatively minor jobs if/when work is being carried out adjacent to the roundabout? Following your involvement with the path to the bus stop, and the replacement bus shelter, I have every faith in your ability to get things done, so I do hope you can wave your magic wand again.

Good afternoon Jocelyn,

I have noticed a triangular area of grass (marked out with wooden pegs) adjacent to the Wiltshire Road/Little Marlow Road roundabout. I thought this might have something to do with the multitude of coloured markings on the grass and pavements in this area, which seem to be for either gas, BT or Swish cabling and manholes. However, it also occurred to me that there might be a proposal to make this into a flower bed, which would be a lovely idea. If so, can I please alert you to the fact that it is common for those walking to and from the Wiltshire Road bus stops to cut across that area - either to go towards The Parkway or to go down Wiltshire Road and it would therefore make sense to lay footpaths on either side of the bed to avoid further damage to the grass.

Whilst on the subject of footpaths, some years ago (2013 in fact) I raised the problem of the missing sections of footpath in Little Marlow Road and Wiltshire Road, and I remember that Councillor Avery called to see me after he had looked at the locations and agreed that they were not very sensible scenarios. My original email said:

*1. Taylor Wimpey have recently installed a new cycleway/footpath running parallel to the sports facilities at Great Marlow School and Little Marlow Road. When undertaking this work, the small footpath from the original footpath to Little Marlow Road was dug up and has not been reinstated. This now means that it is not possible to cross the A4155 from the North side to the South side (adjacent to the Wiltshire Road roundabout) without negotiating rough ground, and is totally unsuitable for wheelchairs or pushchairs.*

*2. Taylor Wimpey have also upgraded the North side of the footpath that runs between Wiltshire Road and Wycombe Road, alongside the sports fields of Great Marlow School. However, while there is a footpath at the bottom of this path to allow pedestrians to cross Wiltshire Road from North to South, there is no corresponding footpath on the South side of Wiltshire Road, so that pedestrians have to negotiate the grass verge and again this is not safe for wheelchairs or pushchairs.*

Bucks Council subsequently issued a CRN number (415397) but to date nothing has happened. Would it be possible to include these 2 relatively minor jobs if/when work is being carried out adjacent to the roundabout? Following your involvement with the path to the bus stop, and the replacement bus shelter, I have every faith in your ability to get things done, so I do hope you can wave your magic wand again.

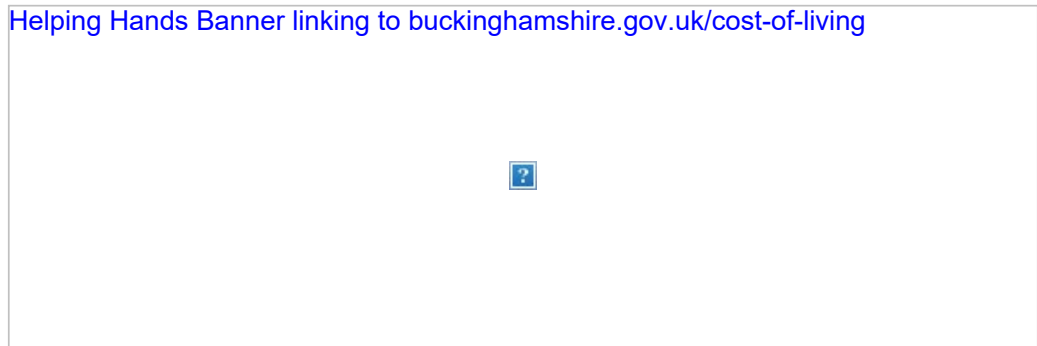
