RC.6.26 Allotment Occupancy Update

Members are advised that the annual allotment renewal for the 2026/27 period has now concluded.

As part of the renewal process, inspections are undertaken across both allotment sites to assess the condition and cultivation of plots. Inspections at Hanging Hill have been completed and allotment holders whose plots were found to be insufficiently worked or not actively cultivated were issued with written correspondence advising that failure to bring the plot back into an acceptable condition could result in their tenancy not being renewed or being terminated. Inspections at Foxes Piece will commence later in May.

Current tenancy and occupancy figures are as follows:

- 93% of Foxes Piece and 98% of Hanging Hill allotment tenancies have been renewed and paid;
- 3 Foxes Piece and 12 Hanging Hill tenants have cancelled their tenancy for the forthcoming year;
- 12 Foxes Piece and 3 Hanging Hill tenancies will be terminated by the Council due to lack of cultivation or non-payment;
- Current allotment availability:
 - Foxes Piece – 3 plots
 - Hanging Hill – 17 plots
- Current waiting list numbers:
 - Foxes Piece – 14 applicants
 - Hanging Hill – 9 applicants
 - Either site – 1 applicant

RC.7.26 Cemetery Test Dig Update - Min Ref: RC.44.25

Members are advised that the Town Council's grave digging contractors have undertaken five test digs between Section B West and Section C of the cemetery to assess the suitability of the area for future full burials, taking account of the significant number of yew trees located within this section. The test digs did not identify any major tree root obstructions, and initial findings indicate that the area is suitable for future use for full burials. Based on the assessment undertaken, it is conservatively estimated that approximately 50 additional full burial plots could be accommodated within this section.
